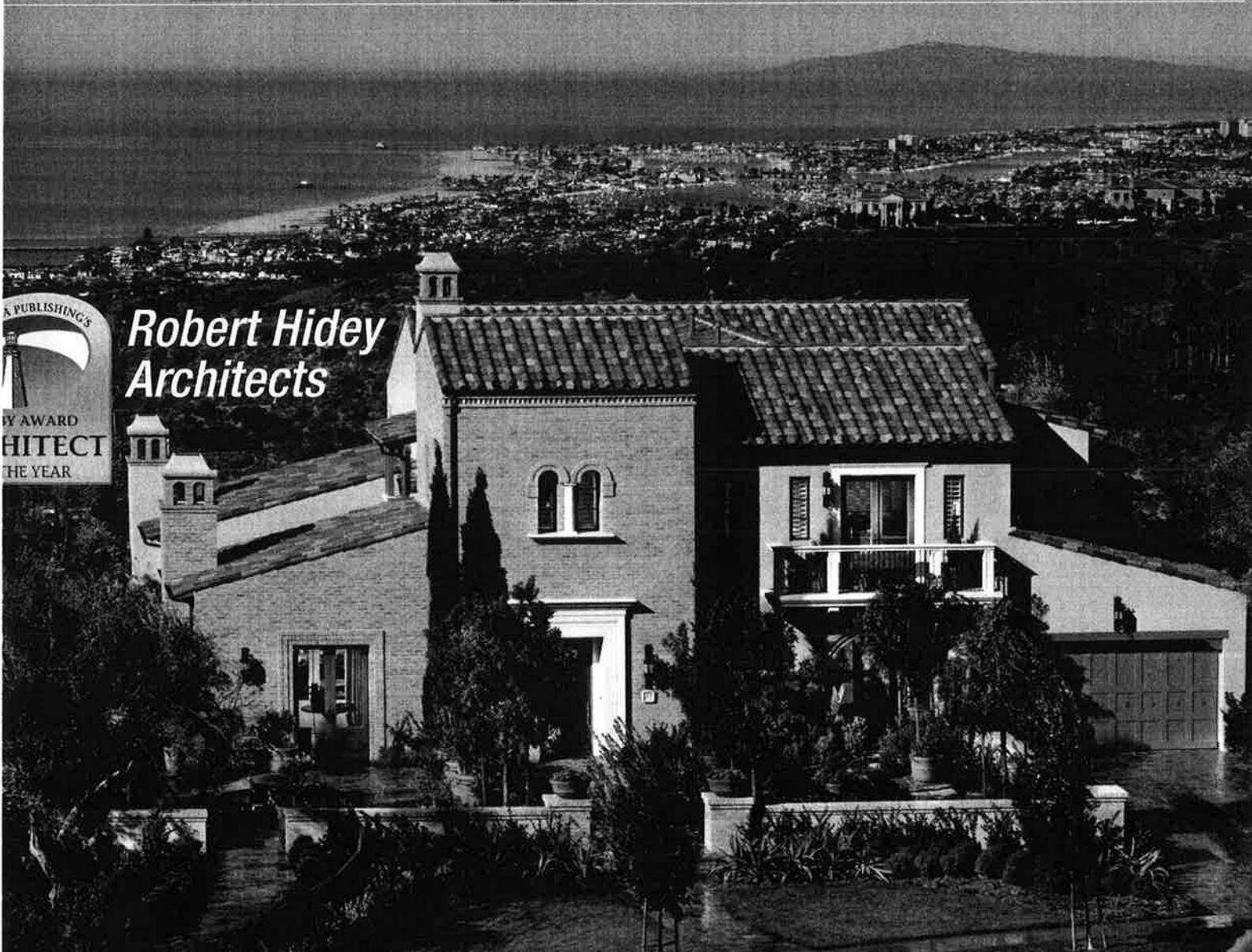

CEO & President, Ashton Woods Homes

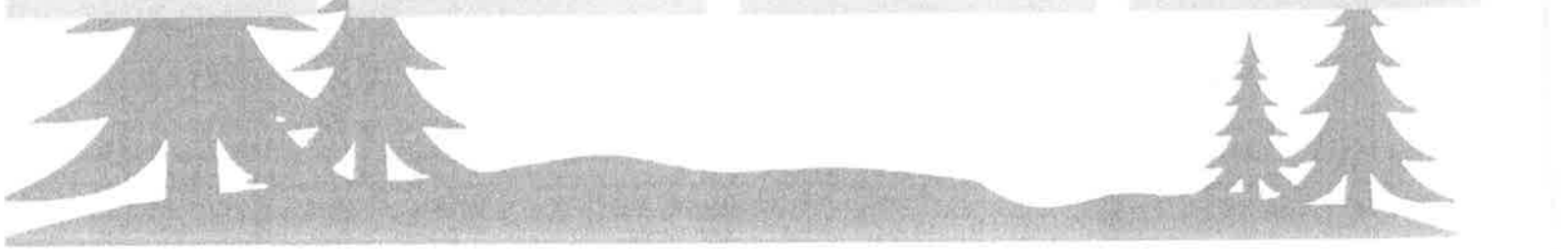
